### **EMERGENCY INFORMATION**

### PART A: NOTIFICATION of an EMERGENCY and / or SCHOOL CLOSURE

We try not to close the school at any stage during the school year but will do so if there is a risk to student and staff health and safety, either within the school or getting to and from school. Where possible, we will notify parents prior to the beginning of the school day.

#### Closure will be due to:

- the school environment being dangerous to students and staff
- we have no essential services for an extended length of time
- extreme weather

Depending on circumstances Official Notification will be through either:

- School website
- Edge Parent App
- Email
- Text message

The main school phone line is to be kept free for Emergency Service only.

### 1. Reunification Plan - Release of your child in or after an emergency or crisis situation

Decisions regarding the release of students from school will be made by management, dependent on the type and level of risk to student safety. If there is any foreseeable risk, students will be cared for at school until they can be released safely.

Please impress upon your child the need for them to follow the directions of any school personnel in times of an emergency and not to leave the school grounds until officially signed out.

In the event of a Local or Regional Civil Defence emergency, for example earthquake, wind event or flooding, where school is the safest place, all students will be kept at school until collected. The time of release and collection may be directed by Civil Defence and/or the NZ Police.

During an extreme emergency, students will be released from a designated collection point, which will be notified to you. When the dangerous incident has subsided, the "all clear" will be advised by Civil Defence or NZ Police and we will begin contacting caregivers.

In some situations, communication may be difficult and we may not be able to release students to persons other than those you have identified on the school emergency contact information (Please see below as to how this can be updated).

#### PLEASE NOTE:

If school closes during a school day:

- those students under the age of 14 years will be kept at school until:
  - 1. We are assured that they can be cared for by a person 14 years or older who has the authority to supervise / care for your child(ren)
  - 2. Collected by a nominated caregiver (as listed on our school records EDGE)
- Older students will be released, when the all clear is given and / or it is safe to travel

## 2. Responsibilities of Parents/Caregivers in case of emergency ... Updating personal Information

Your cooperation is necessary to ensure that we can manage situations that involve the safety of the more than 1100 people who make up our school community on any given day. We need your help in ensuring that we have up-to-date information on any issues that may affect your child's wellbeing or that of our school community.

To ensure that this can happen, we need your up-to-date contact details to contact you at any time, including how to get hold of you in the case of an emergency or school closure.

We need to be assured that we can contact you, or have the contact information for who has your authority to make decisions relating to your child, in an emergency situation.

#### PART B: ILLNESS, PANDEMIC OR CONTAGIOUS DISEASE

There will always be the threat of a pandemic on a local, national, or global scale. In the early stages of any threat to student safety we will communicate the risks and school procedures to you. These will range from hygiene and sickness strategies through to school closure.

If there is an outbreak of a contagious disease in or around a country or region your child or family members have visited, we ask that parents consider the other members of our school community in determining whether their child should have a time of isolation from others at school.

If there is a perceived high risk to New Zealanders of a contagious disease, we will follow the recommendations of health professionals and government agencies.

Parents travelling or living overseas should ensure they have personal plans for the care of their child should there be a need to close the NZ border and/or the school.

### Helping us to keep our community safe and well

Cases of infectious illness occur from time to time in schools. Their importance depends on several factors:

- 1. The severity of the illness
- 2. The number of students and staff affected
- 3. The mode of transmission
- 4. The amount of fear they generate
- 5. Whether any specific action is necessary to stop further cases (e.g. immunisation, improving food-handling practices etc.)

Please consider the other members of our school community when deciding whether your child should be attending school and do not send your child to school if they have a contagious illness. For example, students should not return to school until 24 hours after their last bout of sickness or diarrhoea.

When we have been notified of an 'outbreak' by the District Health Board the stand down period increases to 48 hours after the last episode of sickness or diarrhoea.
